You are required to certify that you will have the sum of **\$23,202** for your own expenses during your first academic year at the University of North Dakota, *excluding* travel expenses. If you plan to continue your graduate studies through the summer, you will need an additional \$7,123 for the three-month period. In computing your expenses, you should note that if you hold a student (F) or exchange visitor (J) visa, you will not be authorized to work except under extraordinary circumstances. Therefore, you should not look to employment, either part-time during the academic year or full-time during the summer, as a significant means of support while at the University of North Dakota. Under no circumstances will you be permitted to work full-time during the academic year.

If you plan to bring your spouse and/or children, a proportionately larger amount of money must be certified. At least an additional \$3,100 per academic year (or \$344 per month) for your spouse and \$1,350 (or \$150 per month) per child must be allocated. Please note that your spouse may apply for permission to work only if you hold a J-1 exchange visitor visa, and then only for his or her and the children's support. Spouses of F-1 student visa holders are not permitted to work under any circumstances.

You are also likely to need this documentation to prove to the United States Consular Officials that you have sufficient funds. We suggest, therefore, that you make copies of all documents for this purpose.
